Please note that if you are making a Data Subject Request and the information you requested reveals details directly or indirectly about another person, we will need to seek the consent of that person before we can disclose that information to you (in the form of written authority from the data subject). In certain circumstances, where disclosure of part or all of the information you have requested would adversely affect the rights and freedoms of others, we may not be able to disclose the information to you, in which case you will be informed promptly and given full reasons for that decision. Please further note that information covered by a legal professional privilege or obligation cannot be disclosed.

Other types of Data Subject Requests are subject to certain conditions and exceptions. We will advise you in writing if we believe that your Data Subject Request fails to meet the requirements of the GDPR in whole or in part.

In most circumstances, Zykrr will provide you with a copy of the information requested free of charge. However, Zykrr may be permitted to charge a reasonable fee if a Data Subject Request is repetitive or manifestly unfounded, or excessive. Zykrr also may charge a reasonable fee to comply with Data Subject Requests for further copies of the same information. The fee will be based on the administrative cost of providing the information.

If you have sent us an invalid request (e.g., without proof or context), we will return your request along with any enclosures and advise you why your application has been rejected.

All information disclosed pursuant to a Data Subject Request is a file copy, as originals are never provided.
